1. Payment and agreement

- 1.1. The Buyer and the Seller have agreed on a purchase price of: € (say ...euro) The buyer has made a deposit of € on and paid the remainder of € at delivery or collection of kitten/cat. The remaining amount must be paid upon collection. If the buyer does not meet his/her purchase obligation, the deposit will be forfeited to the seller. This will also be the case if the buyer does not pick up the kitten/cat on the agreed day or if seller may not deliver the kitten/cat on the agreed day. After 48 hours the seller has the right to offer the kitten/cat for sale again. The Buyer can then no longer make any claim on the kitten/cat and the deposit will revert to the seller.
- 1.2. The kitten/cat has been sold as a pet */ breeding cat */ show cat *
- 1.3. The kitten/cat may WELL * / NOT * be used for breeding

- 1.4. When booking a kitten, a deposit of 25% of the purchase amount will be charged. This deposit is deducted when collecting the kitten. In case of objections and / or cancellations, the deposit will be withheld by the seller / breeder.
- 1.5. The transfer will take place on or on a date to be agreed between the buyer and seller.
- 1.6. The seller hereby declares that the above-mentioned kitten / cat, at the time of the transfer, to the best of its knowledge and after examination by a veterinarian, is completely healthy and free of diseases, abnormalities, parasites and / or skin disorders. The vet will include a health statement in the vaccination booklet. The seller also declares to have given the kitten / cat all the necessary care and attention it needs to grow into a healthy, social kitten / cat and that the animal has had the usual vaccinations and worm treatments for its age.

2. Health guarantee

- 2.1 The seller will make a compensation arrangement with buyer by offering a kitten of the same breed free of charge or a refund of 50% of the purchase price, if it appears that the kitten would die before the age of two years as a result of genetic defects which make the animal unable to grow up and which were not visible (and therefore unknown) to seller and buyer at the time of sale. These are congenital or genetic defects (with the exception of infectious bacteria and viruses that the cat can contract with its new owner). In this report it has to be proven that the kitten actually died from a genetic disorder, this report will have to be made and signed by a recognized and authorized laboratory. Veterinary costs will not be reimbursed by the seller and will at all times be the responsibility of the buyer.
- 2.2 The seller advises the buyer to have the kitten / cat examined by a recognized veterinarian within 5 working days. The seller will make a claim settlement with the buyer by means of reimbursing veterinary costs if the kitten / cat appears to have an infectious disease or virus within 5 days after transfer, which the animal should have contracted from the seller, the vet must provide a statement for this.
- 2.3 In case of the discovery of a (possible) hereditary defect in the kitten/cat during his or her stay life, the buyer is obliged to inform the seller. In this way the seller can decide to exclude certain breeding animals from breeding. Seller is at all times entitled to a second opinion examination by a veterinarian of his choice. The costs of a second opinion examination are for the account of the seller. Buyer is obliged to cooperate with this examination.
- 2.4 Seller declares to only breed with cats that it knows are completely healthy and free from diseases, parasites and known hereditary conditions.

3. Neutering, Spaying / Breeding Agreement

- 3.1 The buyer declares not to be a merchant and to let the kitten grow up as a pet in her home. If the buyer wishes to breed with the kitten at a later date, the seller will advise the seller, if desired, and a supplement will have to be paid to the purchase amount. Seller declares that at the time of the sale there is no contraindication for possible breeding with the kitten.
- 3.2 The kitten will be sterilized for ..-...-... by appointment. Unless the vet has a good reason not to do so. This will also be confirmed by the vet. If this is not the case, the breeding right will still be granted.

- 3.3 The buyer is obligated (if the cat is used for breeding) to examine the cat for the obligatory and tests, and to comply with the breeding regulations of the association which the pedigrees of the pedigrees provided.
- 3.4 The buyer has a fertility guarantee if the buyer buys a kitten with breeding rights. If the cat is not fertile at an age of 2 years, the buyer has to sterilize/castrate the cat and then the buyer gets his breeding rights back from € (say ...euro).

4. 4. Relocation / Transfer / Return placement

- 4.1. The buyer undertakes not to resell the above mentioned kitten/cat to third parties or otherwise allow third parties to dispose of the kitten/cat without the express written consent of the seller.
- 4.2. If, due to circumstances, it is no longer possible to keep the kitten, the buyer must inform the seller. Seller reserves the right to be the first to buy back the kitten for an appropriate price. Or will, if desired, offer support in case of possible reinstatement.
- 4.3. If the kitten / cat is taken back by the seller, an amount will be refunded to the buyer (see point 4.5)
- 4.4. The buyer declares never to place the kitten / cat in a shelter.
- 4.5. The seller declares to take back the kitten at all times, if the buyer is no longer able to take care of the kitten., the buyer is obliged to give the seller the opportunity to take the kitten back and offer it to him again. For this purpose the seller will deduct € 7,- per day from the purchase amount until the kitten is sold. The remaining amount (sale amount - €7,- per day and -25% of the purchase amount) will be paid back to the buyer after the sale.

5. Additional

- 5.1 The buyer declares to give the purchased kitten / cat a loving home and declares not to lock the cat in cages..
- 5.2 The buyer declares to provide the kitten / cat with healthy high-quality food and a hygienic environment.
- 5.3 The buyer declares to provide the kitten / cat with proper medical assistance at all times.
- 5.4 The buyer declares never to declaw the kitten / cat.
- 5.5 The buyer declares not to let the cat run loose outside, and is only allowed out under supervision or in a closed garden / balcony / stay or on a leash.
- 5.6 Cattery CatVision has permission to use photos and videos of the kitten / cat for the website and social media.
- 5.7 It is **IMPORTANT** that you register the kitten / cat with a database such as NDG otherwise the registration remains on the Cattery.
- 5.8 Additional information on how to keep a kitten can be found on our website www.cat-vision.com - Information and service - Important articles - Buying a cat & The cat leaflet - These are easy to download. (Note: this is only in Dutch)

6. Own risk

- 6.1 If the cat comes into contact with other cats after moving, the seller is not liable for any infectious disease.

7. Further provisions

7.1. An amount of 25% of the purchase price applies to the agreements in this agreement stating a deposit as compensation for the breeder. Dutch law applies to this agreement. All legal costs arising from violations of the contents of the provisions and agreements contained in this agreement shall be borne by the buyer. The breeder reserves the right at all times, in the interest of the animal, to cancel the purchase upon transfer. This agreement has been drawn up in duplicate on date, place, the Netherlands and replaces all previous verbal and written agreements and agreements. The undersigned declare that they have read the contents of this agreement and agree to the terms and conditions set forth herein. A copy of this agreement has been provided to the purchaser.
